Scratch box for verification number

- DocuGard 04532 – 13 Security Features
- DocuGard checks are Check-21 compliant

- Prints "VOID" on front when duplicated
  - Patterned background highlights obvious alterations
  - Two-tone colors on front add a layer of security
  - Security warning is printed on front of check
  - Red shield on front is heat-sensitive and disappears if subject to heat or touch
  - Watermark on back can be seen when check is held on an angle
  - Coin-reactive ink on watermark changes color when scratched with a coin
  - Check verification number is part of the watermark
  - Microtext panel contains the DocuSign name and is difficult to copy
  - Anti-spoiler binder deters spilling of information
  - Endorsement area prints "VOID" when duplicated
  - Security Features Box lists tamper-resistant attributes
- Absence of any of these features may indicate alteration.**
