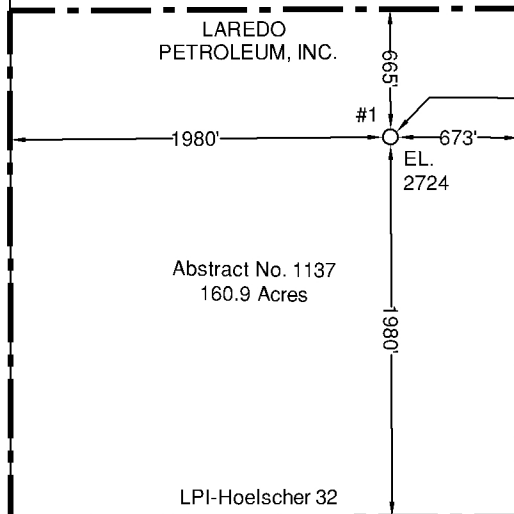
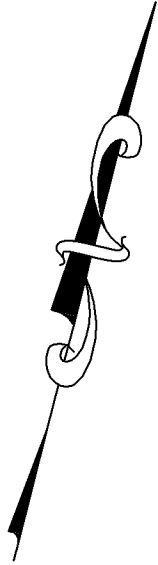

Location is right (South) 650 feet.

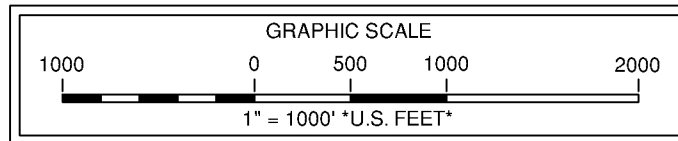
